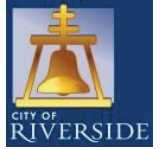


**Oversized Load - Single Trip Permit**  
**City of Riverside – TRANSPORTATION PERMIT – Rules & Regulations**



Cost: The cost of a Single Trip Permit is \$16.00

Loads are allowed to move on City of Riverside streets capable of accommodating the load, except on Victoria Avenue and where posted “Prohibited”.

**Must call 48 hours prior to move for route approval (951) 826-5341, Monday through Friday 7:30 a.m. to 5:30 p.m.**

Permit is NOT valid for County portions of Van Buren, Alessandro and Box Springs Boulevard.

**Recommended Truck Routes are as follows:**

(A Pole Man is required when traveling off recommended Routes with loads larger than 16’ 6” in height.)

- Van Buren - From (or To) North City Limits and To (or From) South City Limits.  
**Loads On Van Buren Over 15’ High Must Hold To Center Lane With A Pole Man On Hand.**  
**Route must divert:** Van Buren to Indiana to Jackson to Lincoln to Van Buren (or Vice Versa).
- From Hwy 215 to City portions of Van Buren to Trautwein to Alessandro to Arlington to Victoria to Lincoln to City portions of Van Buren to Hwy 91.  
**OR** From Hwy 215 to City portions of Van Buren to Trautwein to Alessandro to Chicago to 3<sup>rd</sup>/Blaine to Iowa.
- Magnolia – From (or To) West City Limits to Van Buren (or Vice Versa).
- La Cadena to Columbine to Premier to Interchange (or Vice Versa).
- Market to Rivera to Strong to Main to Columbia to Iowa (or Vice Versa).
- Iowa to Citrus to La Cadena (or Vice Versa).  
**OR** Iowa to Columbia to Main.
- Eastridge to Sycamore Canyon - City Limits - Sycamore Canyon to Martin Luther King to Chicago to Blaine (or Vice Versa).

**No move allowed on:**

- Any City of Riverside street upon which major construction is in progress, except when the load destination is the construction site.
- Saturday or Sunday, Sunset to Sunrise (unless permitted) or Holidays.
- On Victoria Avenue (except as noted above).
- On Main Street between Strong Street and Oakley Avenue between the hours of 7:00 a.m. and 4:00 p.m.
- Any City of Riverside street where posted “Prohibited”.
- **No travel during peak hours with Pilot Car(s) on streets.**

The permit is good ONLY if load dimensions are equal to or less than specified on the permit. If load dimensions exceed any of the categories shown below, then the permit is NULL and VOID.

One (1) pilot car is required if ANY load exceeds one (1) of the following dimensions.

Two (2) pilot cars, Front and Rear of Load are required if ANY load exceeds two (2) or more of the following dimensions.

16 Feet High	12 Feet 6 Inches Wide	95 Feet Long
110 Feet Long (Unladen)	25 Feet Overhang	Towed Unit 6,500 lbs. per Axle

Two (2) pilot cars, Front and Rear of Load are required when moving over any 2-lane portion of routing where sight distance is less than 600 feet, otherwise ONLY one (1) pilot car in front is required.
