## **Transient Occupancy Tax (TOT) Return Form**

Every person providing transient lodging for remuneration in the City of Riverside must collect a tax of thirteen (13%) percent on the rent paid unless that rent qualifies for exclusion or exemption. All allowable exclusions and exemptions must accompany this return form. **This tax is due and payable to the City, on or before the 15<sup>th</sup> day of the month following the close of the reporting period.** For failure to pay the amount prior to the due date, the lodging provider is subject to paying a penalty and interest on the tax due. The penalty is ten (10%) on the first day the tax collected becomes delinquent, twenty five percent (25%) on the thirtieth day of delinquency, and fifty percent (50%) on the sixtieth day of delinquency. The interest rate is one percent (1%) per month or fraction thereof until the date of remittance or payment. *Change of ownership, suspension, or disposal of business must be reported to us immediately.*
