

## CONDITIONS

- Prior to filing of the Conditional Certificate of Compliance, the final parcel to be recognized shall be under a single or an undivided ownership.
- 2. The provisions of public utility easements, water, street lights and electrical underground and/or overhead facilities and fees in accordance with the rules and regulations of the Public Utilities Department.
- 3. Deed for widening Chadbourne to 33 feet from centerline.
- 4. Installation of curb and gutter at 18 feet from centerline, sidewalk and matching pavement on Chadbourne.
- 5. Storm Drain construction will be contingent on engineer's drainage study.
- 6. Off-site improvement plans to be approved by Public Works and a surety posted to guarantee the required off-site improvements prior to building permits being issued.
- 7. Size, number and location of driveways to be approved by Traffic Division.
- 8. Installation of sewers to serve this project.
