RELEASE OF DECLARATION OF RESTRICTIONS

THIS RELEASE is made and entered into this 5th day of May, 1998, by and on behalf of the CITY OF RIVERSIDE, a municipal corporation, with reference to the following facts:

A. On July 5, 1990, MICHAEL M. SLAGLE, executed that certain Declaration of Restrictions relating to his real property located in the City of Riverside, County of Riverside, State of California, described as follows:

Parcel 2 of Parcel Map No. 25166 as shown by map on file in Book 164 of Parcel Maps, at pages 89 and 90 thereof, records of Riverside County, California.

and hereinafter referred to as the "Property". The Declaration of Restrictions was recorded July 17, 1990, as Instrument No. 263223, Official Records of Riverside County, California. The property is presently vacant and has a street address of 1312 Matterhorn Drive, Riverside, California.

- B. In said Declaration of Restrictions dated July 5, 1990, MICHAEL M. SLAGLE, for the purpose of recording a parcel map prior to review by the City of the grading plan for the Property, agreed that a Declaration of Restrictions would be recorded on the Property agreeing that no building permit would be applied for or issued for the development of the Property until a grading plan was approved for the "borrowed" material acquired from the adjoining lot prior to map adoption as set forth in that declaration.
- C. The owners of the Property have requested release from said Declaration of Restrictions dated July 5, 1990, since the conditions contained therein have all been met.
