The undersigned acknowledges that construction of private drainage swales and/or other private drainage facilities may be required across that portion of the above described property shown as shaded area on the attached plat marked as Exhibit A, to convey said drainage waters from the aforementioned public street. The undersigned agrees to maintain said private drainage swales and/or other private drainage facilities in a manner as to not block or impede in any manner the flow of said drainage

waters from said Overlook Parkway.

Dated: March 17, 1984

The undersigned hereby agrees to release the City of Riverside, its officers and employees from any and all claims, demands, suits, or other actions that the undersigned may now or in the future have arising out of or incurred as a result of water discharged from said Overlook Parkway flooding, flowing over or remaining on the above described property.

This Covenant and Agreement shall run with the land and shall be binding upon the undersigned, their heirs, successors and assigns, and shall continue in effect until such time as released by the City Council of the City of Riverside, California, or until said Overlook Parkway is extended onto or through the above described property.


