QUITCLAIM DEED

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, the CITY OF RIVERSIDE, a municipal corporation, does hereby remise, release, and forever quitclaim to J.C.C. ENTERPRISES, INC., a California corporation, the real property in the City of Riverside, County of Riverside, State of California, described as follows:

A portion of that certain easement as conveyed to the City of Riverside, a municipal corporation, by Water Line Easement recorded October 26, 1962, Instrument No. 99712 of Official Records of said Riverside County, lying within Parcels 1 and 2 of Parcel Map 15771, on file in Book 95, Pages 51 and 52 of Parcel Maps, said easement is described as follows:

A strip of land 10.0 feet in width within Lots 17 and 21 of Osborne Heights, as shown on plat on file in Book 12, pages 39, 40 and 41 of Maps, records of Riverside County, California, lying 5.0 feet on each side of the following described center line:

BEGINNING at a point in the most westerly southwesterly line of said Lot 21 distant South 19 ° 44' East, 6.75 feet along said westerly southwesterly line from the most westerly corner of said Lot 21;

THENCE North 28° 03' West, 24.11 feet parallel with said most westerly southwesterly line of Lot 21;

THENCE northwesterly in a straight line a distance of 604 feet, more or less, to a point in the southeasterly line of Lot B of Tract No. 2490, as shown on plat on file in Book 45, pages 5, 6, 7 and 8 of Maps, Records of Riverside County, California; last said point being distant North 35° 54' East, 25.00 feet along said southeasterly line of Lot B from the most southerly corner thereof, and last said point being the end of this center line description.



The side lines of the above described 10.0 foot strip shall be lengthened to terminate southerly in the most westerly southwesterly line of said Lot 21 of Osborne Heights and northerly in the southeasterly line of said Lot B of Tract No. 2490.
