

QUITCLAIM DEED

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, the CITY OF RIVERSIDE, a municipal corporation, does hereby remise, release, and forever quitclaim to TUFFLI COMPANY INCORPORATED, a California corporation, the real property in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of the Northeast Quarter of the Southeast Quarter of the Southwest Quarter of Section 18, Township 2 South, Range 4 West, San Bernardino Meridian, more particularly described as follows:

Parcel 1

That certain easement conveyed to California Electric Power Company by document recorded May 11, 1954, as Instrument No. 23480 of Official Records of Riverside County, described as follows:

The northerly 5 feet of that portion of said Northeast Quarter of the Southeast Quarter of Section 18, lying southeasterly of the Southern Pacific Railroad right-of-way, as now located over and across said Section 18;
