WITNESSETH: That for and in consideration of the sum of \$1.00 in hand paid by the party of the second part to the party of the first part, receipt where is hereby acknowledged, and other valuable consideration, the party of the first part does by these presents grant bargain, sell, convey and confirm unto the said party of the second part and to its successors and assigns forever, all that certain lot or parcel of land situate in the CITY OF RIVERSIDE, County of Riverside, State of California and bounded and particularly described as follows, to-wit:

A portion of Lot 166 of the Southern California Colony Association

Lands, as recorded in Book 7 of Maps, page 3 of records of San Bernardino

County, State of California, said portion being described as follows, to-wit:

Beginning at the Southeasterly corner of Lot 166; thence North 60° 56' West, along the Southerly line of said Lot 84.02 feet to the Northerly line of Terracina Drive as now laid out, said drive being 50 feet wide; thence North 420 45 West along the Northerly line of said drive 55.54 feet; thence continuing westerly on the Northerly line of said drive on the arc of a circle concave to the South and having a radius of 175 feet at a distance of 55.53 feet; thence North 60° 56' West along the Northerly side of said drive 329.50 feet; thence Northwesterly on the arc of a circle concave to the Northeasterly and having a radius of 29 feet, a distance of 52.27 feet to a point on the Easterly property line of Magnolia Avenue, said Avenue being 100 feet in width; thence North 420 20 | East along the Easterly line of said avenue 615.25 feet more or less, to the Northerly line of said Lot 166; thence South 60° 56' East 408.60 feet, more or less, to the Northeasterly corner of said Lot; thence South 290 04!
