That position of Section 21, Township 3 South, Res. 6 West, San Bernardino Base and Maridian, as shown by Sectionalized Servey of Rancho El Sobrante de San Jacinto, on file in Book 1 of Maps, page 8, Records of San Bernardino County, described as follows:

Beginning at a point in that certain course described as "South 56° 29' 53" Rast, 120.04 feet", in Deed to the State of California, recorded February 20, 1959, in Book 2418 of Official Records, page 411, Records of Riverside County, distant along said course N 56° 29' 53" W, 16.69 feet from the southeasterly terminus thereof;

Thence N 61° 06' E, 214.50 feet; Thence S 11° 46' 06" E, 94.10 feet to a tangent curve concave westerly with a radius of 25 feet;

Thence southerly along said curve through an angle of 58° 32' 23", an arc length of 25.54 feet;

Thence S 46° 46' 17" W, 151.83 feet to a tangent curve concave northerly with a radius of 48 feet;

Thence westerly along said curve through an angle of 114° 17' 40", an arc length of 95.75 feet;

Thence N 18° 56' 03" W, 70.71 feet to a tangent curve concave southwesterly with a radius of 45 feet;

Thence northwesterly along said curve through an angle of 25° 35' 15", an arc length of 20.09 feet to a point in the southeasterly line of the State Highway which bears 8 61° 06' W, 25.94 feet from the point of beginning.

Thence N 61° 06' E, 25.94 feet to the point of beginning.

Excepting therefrom the northwesterly rectangular 15 feet.
