FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, the CITY OF RIVERSIDE, a municipal corporation, does hereby remise, release, and forever quitclaim to LEONARD E. TEYSSIER and MONICA TEYSSIER, husband and wife as joint tenants, the real property in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of Lot 7 (known as storm ditch) in Block 41 as shown by map entitled "Map of Subdivision of Lots 3, 4, 5 and 6, Block 41, Arlington Heights," on file in Book 6, Page 86 of Maps, records of said Riverside County, described as follows:

BEGINNING at the most southerly corner of Lot 3 in said Block 41; said corner being in the northeasterly line of said Lot 7;

THENCE South 46° 30' East, along said northeasterly line 207.11 feet to a line which is parallel with and distant 457.80 feet northwesterly as measured at right angle from the southeasterly line of Lot 5 in said Block 41;

THENCE South 56° 00' West, along said parallel line 20.49 feet to the southwesterly line of said Lot 7;

THENCE North 46° 30' West, along said southwesterly line 207.11 feet to the southwesterly prolongation of the southeasterly line of said Lot 3;

THENCE North 56° 00' East, along said southwesterly prolongation of the southeasterly line of Lot 3, a distance of 20.49 feet to the POINT OF BEGINNING.




