Also reservation of all riparian water rights in the Santa Ana River appurtenant to said land and all riparian and other water rights in Spring Brook as described in said Deed.

A Mortgage executed by Frank Wyatt and Pauline V. Wyatt, his wife, in favor of Oscar W. This Certificate and Guarantee are issued upon the following conditions and stipulations:

1. No provision or condition thereof can be walved or changed except by writing endorsed hereon or uttached bereto and signed by the President, a Vice-President, the Secretary or an Assistant Secretary of the Abstract Company and of the Insurance Company.




