WITNESSETH: That the said parties of the first part, for and in consideration of the sum of Ten and no/100- - - - - (\$10.00) - - - - - Dollars,

of the United States of America, to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, have remised, released, and forever quitclaimed, and by these presents do remise, release and forever quitclaim, unto the said party of the second part, and to its heirs and assigns, all those certain water rights appurtenant to the following described the certain lot, piece or parcel of land situate, lying and being in the City of Riverside County of Riverside, State of California, and bounded and particularly described as follows, to-wit:

Lot "M" of Rivera Tract as shown by Map on file in Book 10 page 4 of Maps, records of Riverside County, California.

Which said water rights are represented by any interest in the Capital Stock of the Twin Springs Water Company, a corporation, being Certificate No. 73 covering 2 shares of the Capital Stock of the Twin Springs Water Company, or the property and water rights belonging thereto, together with the right to receive all water from said company, right to receive which has heretofore belonged to the owner of said land and said Capital Stock.

Together with the right to remove said water and use the same whenever and wherever desired by City of Riverside, its successors and assigns.

Together with the right to remove, use and take any water belonging to or developed by the Twin Springs Water Company or any stockholder thereof which may now be appurtenant to any of the land described in the Articles of Incorporation of said Company.

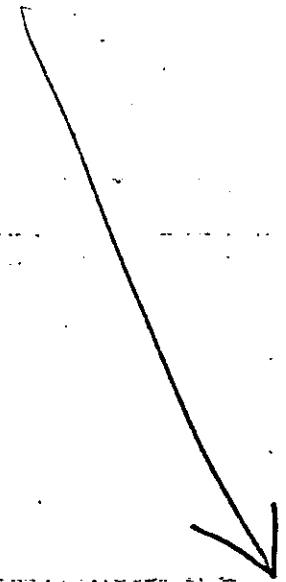
