WHEREAS, this Board did, on the ^{13th}~~10th~~ day of August, 1936, in regular open meeting, by a vote of two-thirds of all its members, adopt a resolution declaring the intention of said Board to dedicate to the City of Riverside for public street and highway purposes, and without consideration, the real property hereinafter described, and fixed the 8th day of ~~August~~^{September}, 1936, as the date for a public meeting of said Board to be held at its regular place of meeting for a public hearing upon the question of making such dedication; and

WHEREAS, notice of the adoption of said resolution and of the time and place of holding said meeting has been duly given as provided in section 6.192a of the School Code; and

WHEREAS, at the time and place fixed in said resolution for the meeting of said Board such public hearing was duly held; and

WHEREAS, at said public hearing, no petition or protest against said proposed dedication was filed with said Board, and no person appeared to object to the same,



16 Magnolia Avenue to Brockton Avenue, be, and the same is hereby, accepted; and




