That in consideration of the sum of One Dollar (\$1.00) lawful money of the United States to the said party of the first part in hand paid by the said party of the second part, receipt whereof is hereby acknowledged, said party of the first part does by these presents grant unto the said party of the second part, its successors and assigns, an easement and right-of-way for the erection and maintenance of poles, electric lines, wires of all descriptions and equipment, overhanding at a minimum distance from the surface of the ground, as specified by the California Railroad Commission, over and across that certain real property situate in the City of Riverside, County of Riverside, State of California, and particularly described as follows, to-wit:-

A right-of-way five (5) feet wide, being two and one-half (2-1/2) feet on each side of a line two and one-half (2-1/2) Southerly from and running parallel to the most northerly line of Lots Twenty-two (22) to Thirty-five (35), both inclusive, of Palmwood Subdivision, according to map thereof recorded in Book of Maps Sixteen (16) page Eighty-two (82), records of Riverside County, California, said line extending from the westerly line of Brockton Avenue to the easterly line of Palm Avenue shown on said filed map.


