WITNESSETH: That in consideration of the premises and other valuable considerations, receipt of which by the said party of the first part is hereby acknowledged, said party of the first part does by these presents remise, release, and forever quitclaim unto said party of the second part, and its successors and assigns forever, all water and water rights located, arising or for use upon, constituting a part of or appurtenant to those certain premises, including all public streets, alleys and thoroughfares abutting thereon, situate in the City of Riverside, County of Riverside, State of California, described as follows: That portion of Lot 87 in Division C of Hall's Addition to Riverside, as shown by map recorded in Book 9 of Maps page 3, San Bernardino County records, described as follows:- beginning at a point on the westerly line of said Lot 87, 16 feet northerly from the southwesterly corner of said Lot, said point being located on the easterly line of Park Ave; thence easterly parallel with the southerly line of said Lot 87, 106 feet and 10 inches; thence at a right angle northerly 80 feet; thence at a right angle westerly 106 feet 10 inches to the easterly line of Park Ave; thence southerly 80 feet to point of beginning;




