## WITNESSETH:

That for an in consideration of the sum of One and no/100 (\$1.00) Dollars, the first party does grant, bargain, sell and convey to the second party, an easement of right-of-way over and across the right-of-way of the Riverside Water Company Canal for street purposs, that certain real property situate in the City of Riverside, County of Riverside, State of California, more particularly described as follows:
