

GRANT DEED

In consideration of One and No/100 -- Dollars

R. C. Lewis and Grace V. Lewis, husband and wife

Do hereby grant to the City of Riverside, all that real property situate in the City of Riverside, County of Riverside, State of California, described as follows:

A strip of land sixty-six feet in width, being thirty-three feet on each side of a certain center line, said center line being described as follows:

Hillside Ave

Beginning at a point in the north line of Section 32 T. 2 S. R. 5 W. S.B.B.M. 8.00 feet west from the quarter corner; thence South 0°01'40" West parallel to the Northerly and Southerly center line of said Section 32 a distance of 2365.93 feet to the beginning of a curve concave to the West and having a radius of 1850.00 feet; thence Southwesterly along said curve through an arc of 8°40' a distance of 279.85 feet; thence South 8°41'40" West a distance of 565.25 feet to the beginning of a curve concave to the Northwest and having a radius of 900.00 feet; thence Southwesterly along said curve through an arc of 11°47'30" a distance of 185.35 feet; thence South 20°29'10" West a distance 261.32 feet to the beginning of a curve concave to the Northwest and having a radius of 1500.00 feet; thence Southwesterly along said curve through an arc of 3°07'30" a distance of 81.81 feet; thence South 25°36'40" West a distance of 245.75 feet to the beginning a curve concave to the east and having a radius of 500.00 feet; thence Southerly through an arc of 26°45' a distance of 233.44 feet; thence South 3°08'20" East a distance of 6.67 feet to the beginning of a curve concave to the Northwest and having a radius of 400.00 feet; thence Southwesterly along said curve through an arc of 63°40' a distance of 144.48 feet; thence South 60°31'40" West a distance of 22.96 feet to the beginning of a curve concave to the Southeast and having a radius of 500 feet; thence Southwesterly along said curve through an arc of 30°22'10" a distance of 265.02 feet; thence South 30°09'30" West a distance of 56.62 feet to the beginning of a curve concave to the Northwest and having a radius of 600 feet; thence Southwesterly along said curve through an arc of 24°19'15" a distance of 254.69 feet; thence South 54°22'45" West a distance of 324.80 feet to the beginning of a curve concave to the Southeast and having a radius of 150.0 feet; thence Southerly along said curve through an arc of 54°55'35" a distance of 143.8 feet; thence South 0°26'50" a distance of 35.63 feet to the center line of Arlington Avenue; said point being South 89°33'10" West a distance of 28.0 feet from the Southeast corner of the Southwest one quarter of the Southwest one quarter of said Section 32.
