EASEMENT

THIS INSTRUMENT, made this 5th day of October in the year of our Lord, nineteen hundred and forty-five, between Maurice J. Robinson A. L. Smith, C. Serles, Robert G. W. Bennett, Juanita V. Bennett, Ella H. Smith, Yvonne E. Smith, Marie Serles, PARTIES OF THE FIRST PART, AND THE CITY OF RIVERSIDE, a municipal corporation of the State of California, the party of the second part; WITNESSETH: That said party of the first part, for and in consideration of the sum of one dollar (\$1.00) lawful money of the United States of America, to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, do by these presents grant unto said party of the second part, a perpetual easement and right of way for the construction, reconstruction, inspection, maintenance, operation and repair of SANITARY SEWERS, hereinafter termed "structure", in, under and along that certain parcel of land in the City of Riverside, County of Riverside, State of California, described as follows, to-wit:

Right of way for sewer ten (10) feet in width lying five (5) feet on each side of a line described as follows:

Beginning at a point in the easterly line of Ottawa Avenue 145 feet southerly from the southerly line of eighth Street, thence easterly parallel to the southerly line of Eighth Street to the easterly line of Lot 2, Castleman Addition, as shown in Book 3 of Maps, Page 19, records of San Bernardino County, California.

Together with the right to enter upon and to pass and repass over and along said strip of land, and to deposit tools, implements and other material thereon by said party of the second part, its officers, agents, and employees, and by persons under contract with it and their employees, whenever and wherever, necessary for the purpose of constructing, reconstructing, inspecting, maintaining, operating or repairing said structure.

It is understood that the Grantors herein own a portion only of the above described right of way and by their signatures convey only that portion owned by each of them.

In consideration of the foregoing grant, the party of the second part hereby agrees that in the event said structure is constructed, same shall be constructed in a first-class, workmanlike manner.
