

This Indenture, Made the 9<sup>th</sup> day of May

Lybster of the City of Riverside County of San Bernardino State of California the parties of the first part, and The Trustees or their Successors in Trust of the City of Riverside County of San Bernardino State of California part 4 of the second part,

Witnesseth: That the said part of the first part, for and in consideration of the sum of Five Dollars,

lawful money of the United States of America, to them in hand paid by the said part 4 of the second part, the receipt whereof is hereby acknowledged, do by these presents grant, bargain, sell, convey and confirm unto the said part 4 of the second part, and to its heirs and assigns forever, all that certain lot, piece or parcel of land situate, lying and being in the County of San Bernardino, State of California, and bounded and particularly described as follows, to wit:

Commencing at the hundred and twenty feet (120) Eastely from the North West Corner of Lot One (1) Block Six (6) as shown on a plat of "Whites Addition to Riverside" surveyed by G. O. Furman of record in the County Recorder Office San Bernardino County State of California running thence Eastely along and on Fifth Street twenty feet (20) thence Southely and at right angles with Fifth Street three Hundred and thirty feet (330) to Sixth Street thence Westely along and on Sixth Street Twenty Feet (20) thence Northely and at right angles with Sixth Street three Hundred and thirty feet (330) to Fifth St to the point of beginning. The property intended to be conveyed is the Westely twenty feet (20) of Lots three (3) and Twenty Six (26) of Block Six (6) Whites Addition and to be used as a public thorough fare forever

Together with all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

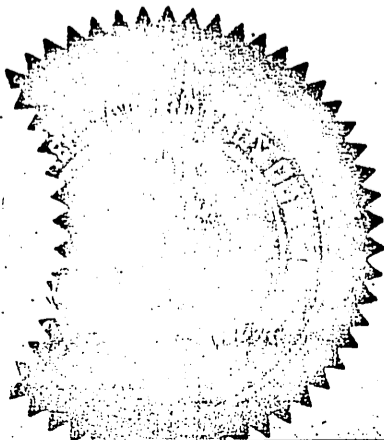
