A strip of land over and across the entire Easterly twenty (20) feet of the North one-half (1/2) of the Northeast one-quarter (1/4) of the Northeast one-quarter (1/4) of the Southwest one-quarter (1/4) of Section 32, Township 2 South, Range 5 West, San Bernardino Base and Meridian:  
EXCEPTING therefrom, that portion lying within the boundaries of Hillside Avenue.
