GRANT DEED

HELEN L. RUTH, Grantor, for a valuable consideration, receipt of which is hereby acknowledged, does hereby grant to CITY OF RIVERSIDE, a Municipal Corporation, the real property in the City of Riverside, County of Riverside, State of California, described as follows:

A portion of Lot 1 and a portion of Lot 2 of the Victoria Arroyo Tract, as shown on a map recorded in Book 8, at page 49, Records of Riverside County, California, and more particularly described as follows:

Beginning at a point marked "14" on said map of Victoria Arroyo Tract; thence North 60° 26' West along the center line of Arroyo Drive as shown on said map a distance of nineteen and ninety-hundredths feet (19.90) to a point; thence North 29° 34' East, perpendicular to said center line at said point a distance of twelve and fifty-hundredths feet (12.50) to a point on the northerly line of said Arroyo Drive; thence South 60° 26' East a distance of forty-four and forty-one hundredths feet (44.41) to a point; thence southeasterly along a curve concave to the northeast, having a radius of two hundred seventeen feet (217) through a central angle of 23°33', a distance of eighty-nine and nineteen hundredths feet (89.19) to a point; thence South 83° 59' East, a distance of ninety-two and forty-nine hundredths feet (92.49) to a point; thence easterly along a curve concave to the north, having a radius of three hundred thirty-seven feet (337) through a central angle of 20°, a distance of one hundred seventeen and sixty-four hundredths feet (117.64) to a point on the northerly line of said Arroyo Drive; thence South 13°59' East, perpendicular to the center line of Arroyo Drive at said point a distance of twelve and fifty hundredths feet (12.50) to a point on the center line of Arroyo Drive; thence South 76° 01' West, along the center line of Arroyo Drive as shown on said map a distance of thirty-five and eighty hundredths feet (35.80) to a point marked "22" on said map; thence westerly along the center line of Arroyo Drive through five courses, as shown on said map of Victoria Arroyo Tract, to the point of beginning; excepting therefrom that portion thereof included in Arroyo Drive as shown on said map.
