RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
RIVERSIDE, CALIFORNIA, CHANGING STREET NAMES.

WHEREAS, the Planning Commission of the City of Riverside has recommended, and the City Council has determined, that the names of hereinafter designated streets or portions of streets be changed, to prevent confusion from similarity of names of other streets.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside that the names of the hereinafter designated streets and portions of streets are changed as follows:

(1) KELLY STREET to LOMITA STREET; said Kelly Street being from Arlington Avenue westerly 963.55 feet, as shown on a map of Gafford Gardens recorded in Map Book 12 at page 97, Records of Riverside County.

(2) FAIRMOUNT STREET to WILSHIRE STREET; said Fairmount Street being from 300.81 feet southerly from the southerly line of Hendry Street to 420.75 feet northerly from the northerly line of Hendry Street, as shown on a map of Files Subdivision recorded in Map Book 5 at page 129, Records of Riverside County; and on a map of Files Subdivision No. 2 recorded in Map Book 5 at page 137, Records of Riverside County.

(3) PEPPER STREET and RUBIDOUX DRIVE to REDWOOD DRIVE; said Pepper Street being from the northerly line of Fourteenth Street to the center line of Fifth Street; and said Rubidoux Drive being from the center line of Fifth Street to the southerly extension of the easterly line of Lakehill Place.

(4) Portion of REDWOOD DRIVE to FIELD LANE; said portion of Redwood Drive being from Dexter Drive westerly 870 feet, plus or minus, and lying along the southerly line of Lots K and S of Amended Map of Indian Hill Tract, shown on a map recorded in Map Book 10 at page 3, Records of Riverside County.

1 (5) PRENDA STREET to MUIRFIELD ROAD; said Prenda Street  
2 being from the southerly line of Washington Street to the  
3 northerly line of Conduit Street, as shown on a map of Osborne  
4 Heights, recorded in Map Book 12, at page 40, Records of Riverside  
5 County.

6 (6) Portion of BANKS DRIVE to REDWOOD DRIVE; said portion  
7 of Banks Drive as said Drive exists between Redwood Drive and  
8 Locust Street, in Fairmount Park, extending easterly from  
9 Redwood Drive a distance of approximately 350 feet to its inter-  
10 section with a road extending northerly across the dam over a  
11 portion of Fairmount Park Lake.

12 (7) To REDWOOD DRIVE; that road extending northerly from  
13 Banks Drive, as same exists in Fairmount Park between Redwood  
14 Drive and Locust Street, across the dam over a portion of Fairmount  
15 Park Lake, to its intersection with the road extending easterly  
16 along the northerly side of said Fairmount Park Lake; also that  
17 road in said Fairmount Park extending northerly from its inter-  
18 section with Redwood Drive westerly, to its intersection with  
19 Crestmore Avenue.

20 (8) Portion of REDWOOD DRIVE to DEXTER DRIVE; said Redwood  
21 Drive extending easterly from the westerly line of Dexter Drive  
22 to its intersection with the road in Fairmount Park extending  
23 Northerly and southerly, together with that portion of said park  
24 road southerly and easterly along the northerly side of Fairmount  
25 Park Lake to its intersection with the park road extending northerly  
26 and southerly past the easterly end of said Fairmount Park Lake.
