15 and by means of one line of poles, with supporting structures,  
16 crossarms, wires, guys, anchors, fixtures and appurtenances, for  
17 the transmission of electric energy for any and all purposes for  
18 which the same may be used, and communication purposes upon, over,  
19 and across that certain real property, situate in the County of  
20 Riverside, State of California, described as follows:

14 The Northeastly 10 feet of that portion of  
15 Lot 5, Block 53 of Arlington Heights as recorded in  
16 Book 11, pages 20 and 21 of Maps, Records of San  
17 Bernardino County, California; starting at the North-  
18 east corner of said Lot 5, Block 53; Thence parallel  
19 and in a Southwesterly direction along the common line  
20 of Lots 3 and 5 a distance of 499.98 feet.

19 across which said easement and right-of-way is granted, for the  
20 purpose of installing, maintaining and repairing said poles, lines,
