RESOLUTION NO. 6799

1 RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
 2 RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING
 3 A PORTION OF PUBLIC UTILITY EASEMENT OVER A PORTION
 4 OF LOT 1 OF ADAM CLARKE SUBDIVISION.

5 WHEREAS, on the 24th day of May, 1945, Ordinance No. 2207
 6 of the City of Riverside, California, was adopted, declaring the
 7 intention of the City Council to vacate a portion of public
 8 utility easement over a portion of Lot 1 of Adam Clarke Subdivi-
 9 sion, pursuant to the provisions of the Public Service Easements
 10 Vacation Law; and,

11 WHEREAS, in said ordinance the time of hearing was set for
 12 Tuesday, July 19, 1945, at 10 o'clock A. M. in the Council Chambers
 13 located in the City Hall, Seventh and Orange Streets, Riverside
 14 California, at which said time and place all persons interested
 15 in or objecting to the proposed vacation be allowed to be heard;
 16 and,

17 FURTHER, notice of hearing was given as provided by Section
 18 50401 of the Government Code of the State of California; and,

19 WHEREAS, a hearing of the ordinance of intention was had
 20 before said legislative body at the time and place fixed, at
 21 which time the evidence offered by persons interested was heard
 22 by the legislative body; and the legislative body found from all
 23 of the evidence submitted that the portion of a public utility
 24 easement which the legislative body declared its intention to
 25 vacate is unnecessary for present or prospective public use.

26 NOW, THEREFORE, IT IS ORDERED by the City Council of the
 27 City of Riverside, California, that a portion of a public utility
 28 easement over a portion of Lot 1 of Adam Clarke Subdivision, in
 29 the City of Riverside, County of Riverside, State of California,
 30 and described as follows:

31 The northwesterly five feet (5') of the south-
 32 easterly ten feet (10') of Lot 1 of Adam Clarke
 Subdivision, as shown on a map recorded in Map

1 Book 24 at pages 69 and 70, Records of Riverside
2 County, EXCEPTING THEREFROM the northerly ten
3 feet (10') measured at a right angle to the
4 northerly line of said Lot 1;

5 is unnecessary for present or prospective use, and that the same
6 be and is hereby vacated.

7 IT IS FURTHER ORDERED THAT the Clerk cause a certified copy
8 of this order, attested by him under seal, to be recorded in the
9 Office of the County Recorder of Riverside County, California.

10 ADOPTED by the City Council, signed by the Mayor, and
11 attested by the City Clerk this 15th day of July, 1955.
