RESOLUTION NO. 6970

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING PORTIONS OF PUBLIC UTILITY EASEMENTS OVER LOT 28, DONALD AVENUE EXTENSION TRACT.

WHEREAS, on the 27th day of September, 1955, Ordinance No. 2260 of the City of Riverside, California, was adopted, declaring the intention of the City Council to vacate portions of public utility easements over Lot 28, Donald Avenue Extension Tract, pursuant to the provisions of Public Service Easements Vacation Law; and,

WHEREAS, in said ordinance the time of hearing was set for Tuesday, November 22, 1955, at 10:00 o'clock A.M. in the Council Chambers located in the City Hall, Seventh and Orange Streets, Riverside, California, at which said time and place all persons interested in or objecting to the proposed vacation be allowed to be heard; and,

WHEREAS, notice of hearing was given as provided by Section 50441 of the Government Code of the State of California; and,

WHEREAS, a hearing of the ordinance of intention was had before said legislative body at the time and place fixed, at which time the evidence offered by persons interested was heard by the legislative body; and the legislative body found from all of the evidence submitted that the portions of the public utility easements which the legislative body declared its intention to vacate are unnecessary for present or prospective public use.

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that the portions of the public utility easements over Lot 28, Donald Avenue Extension Tract, in the City of Riverside, County of Riverside, State of California, and described as follows:

That portion of the public utility easement shown on a map of Donald Avenue Extension Tract recorded in Map Book 25, at page 99, Records of Riverside County, being the south-easterly five feet (5') of the southwesterly one

2 westerly twenty-two feet (22') of the north-
easterly ten feet (10') of Lot 28 of said Tract;

3 are unnecessary for present or prospective public use, and that
4 the same be and are hereby vacated.
