

RESOLUTION NO: 7541

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A DRAINAGE EASEMENT OVER A PORTION OF LOT 37, BLOCK 7, TIBBETS TRACT;

WHEREAS, on the 16th day of October, 1956, Ordinance No. 2434 of the City of Riverside, California, was adopted, declaring the intention of the City Council to vacate a drainage easement over a portion of Lot 37, Block 7, Tibbets Tract, pursuant to the provisions of the Public Service Easements Vacation Law; and,

WHEREAS, in said ordinance the time of hearing was set for Tuesday, December 11, 1956, at 10:00 o'clock A. M. in the Council Chambers located in the City Hall, Seventh and Orange Streets, Riverside, California, at which said time and place all persons interested in or objecting to the proposed vacation be allowed to be heard; and,

WHEREAS, notice of hearing was given as provided by Section 50441 of the Government Code of the State of California, and,

WHEREAS, a hearing of the ordinance of intention was had before said legislative body at the time and place fixed, at which time the evidence offered by persons interested was heard by the legislative body; and the legislative body found from all of the evidence submitted that the drainage easement which the legislative body declared its intention to vacate is unnecessary for present or prospective public use.

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that the drainage easement over a portion of Lot 37, Block 7, Tibbets Tract, in the City of Riverside, County of Riverside, State of California, and described as follows:

The southerly four feet of Lot 37 in Block 7 of the Tibbetts Tract, as shown by map thereof on file in the office of the County Recorder of the County of Riverside, State of California, in Book 4 of Maps, page 91 thereof; is unnecessary for present or prospective public use, and that the same be and is hereby vacated.

IT IS FURTHER ORDERED that the City Clerk cause a certified copy of this order, attested by him under seal, to be recorded in the Office of the County Recorder of Riverside County, California.
