EASEMENT

TOGETHER WITH the right of entry upon said premises over and across which said easement and right-of-way is granted, for the purposes of installing, maintaining and repairing said poles, lines, wires, and equipment, and to enjoy the use of sail easement and right-of-way free and clear of buildings, trees and other obstructions.
