WITNESSETH: That the said parties of the first part, for the purpose of public convenience, does hereby REMISE, RELEASE and FOREVER QUIT-CLAIM unto the said party of the second part, all that certain piece of land, situate, lying and being in the City of Riverside, County of Riverside, State of California, and particularly described as follows, to-wit:

Beginning at a point on the Westerly line of and distant Thirty-three and sixty-six hundredths (33.66) feet Southerly from the North-westerly corner of Lot Six (6), in Block Eight (8), Range Seven (7) of the Town of Riverside, as surveyed by Goldsworthy and Higbie, a plat of which is of record in the office of the County Recorder of the County of San Bernardino, State of California, in Book 7 of Maps, at pagel7 thereof, for an initial point; thence in a North-easterly direction a distance of Thirty-six and seven-tenths (36.7) feet, more or less, to a point, said point being situated Fourteen (14) feet Southerly of the Northerly line and Thirty-one (31) feet Easterly of the Westerly line of said Lot Six (6); thence Southerly and part allel with said Westerly line a distance of Twenty and thirtyfour hundredths (20.34) feet to a point; thence in a South-westerly direction a distance of Ten and six-tenths (10.6) feet, more or less to a point, said point being Forty (40) feet Southerly of the Northerly line and Twenty-two, and eight-hundredths (22.08) feet Easterly of the Westerly line of said Lot Six (6)

thence Westerly and parallel with the Northerly line of said Lot Six (6) a distance of Twenty-two and eight-hundredths. (22.08) feet to a point in the Westerly line of said Lot Six (6); thence Northerly along said Westerly line a distance of Six and thirty-four hundredths. (6.34) feet to the point of beginning.

Reserving to the said S. A. White the right to construct one or more tunnels across the alley abutting his property, or to construct a bridge thereover, provided that the same shall not interfere with the public use of said alley.

TO HAVE AND TO HOLD unto the said party of the second part upon the condition that the said S. A. White be permitted to connect his present property in said Block Eight (8) with the sewer And the said party of the second part by on Market Street. the acceptance of this deed covenants and agrees to and with the said parties of the first part that it, the said City of Riverside, shall, upon the petition of the owners of a majority of the frontage upon said alley immediately cause said alley to be improved under the Vrooman Act so called by grading the same and paving the surface with four inches of Portland Cement concrete and surfacing the same with two inches of asphalt cement, and that if within twelve years from the date hereof the said party of the second part shall cause or allow any removal of any part of said concrete pavement, it will within thirty days from said removal, replace said concrete and resurface the alley with same kind of asphalt cement surface.
