3 day of October, in the year of our Lord, Nineteen
4 hundred and fifty-seven, by and between Lawrence Coffey and
5 Vera S. Coffey, husband and wife, Mort E. Kilday and Louise
6 M. Kilday, husband and wife, Norma L. Coupland, a married
7 woman, as her separate property, David S. Lackie and Maris
8 G. Lackie, husband and wife, and Thomas C. Whiffen and Joyce
9 Joyce C. Whiffen, husband and wife, parties of the first
10 part, and the City of Riverside, a municipal corporation of
11 the State of California, party of the second part:

12 WITNESSETH: That the above named parties of the

15 receipt whereof is hereby acknowledged, do by these presents

of 317.00 feet; thence N 33° 52' W a distance
