3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY
4 OF RIVERSIDE, CALIFORNIA, DEDICATING LAND
5 OWNED BY THE CITY OF RIVERSIDE TO PUBLIC USE
6 FOR STREET PURPOSES.

7 (Widens Main Street and Orange Street
8 North of Santa Ana Street)
9

10 BE IT RESOLVED by the City Council of the City of Riverside:

11 (a) That the herein described strip or parcel of land owned
12 by the City of Riverside lying east of and adjacent to Main
13 Street north of Santa Ana Street, be and is hereby dedicated
14 by the City of Riverside to public use for street purposes, to
15 become and be a part of Main Street.

16 Said parcel or strip of land is located in the City of
17 Riverside, County of Riverside, State of California, and is
18 described as follows:

19 That portion of Lot 57 of the Alamo Tract, as
20 shown by map on file in Book 9, page 5 of Maps,
21 Records of Riverside County, California, described
22 as follows:

23 Commencing at the southwesterly corner of said
24 Lot 57, said point being the intersection of the
25 easterly line of Rialto Road with the northerly line
26 of Santa Ana Street, as shown on said map;

27 Thence North 4° 10' East, parallel with and 33
28 feet measured at right angles easterly from the center
line of said Rialto Road, 20.94 feet to the true
point of beginning;

29 Thence continuing North 4° 10' East, parallel
30 with the center line of Rialto Road, 567.20 feet to an
31 intersection with the easterly line of a Storm Water
32 Ditch as shown on map of said Alamo Tract;

Thence North 40° 33' East, along the easterly line
of said Storm Water Ditch, 14.76 feet;

Thence North 32° 10' East, continuing along the
easterly line of said Storm Water Ditch, 17.64 feet;

Thence South 4° 10' West, parallel with and 50 feet,
measured at right angles easterly from the center line
of said Rialto Road, 592.50 feet;

Thence South 20° 23' 30" East, a distance of 16.86
feet;

Thence North 60° 57' West parallel with and 44 feet,
measured at right angles, northerly from the center line
of Santa Ana Street, as shown on map of said Alamo Tract,
a distance of 28.74 feet to the true point of beginning.

(b) That the herein described strip or parcel of land owned
by the City of Riverside lying west of and adjacent to Orange

1 Street north of Santa Ana Street, be and is hereby dedicated
2 by the City of Riverside to public use for street purposes, to
3 become and be a part of Orange Street.

4 Said parcel or strip of land is located in the City of
5 Riverside, County of Riverside, State of California, and is
6 described as follows:

7 That portion of Lot 57 of the Alamo Tract as
8 shown by map on file in Book 9, page 5 of Maps,
records of Riverside County, California, described
as follows:

9 Beginning at a point on the southeasterly line
10 of said Lot 57, which bears North 29° 03' East, a
distance of 19 feet from the southeast corner of
said Lot 57;

11 Thence North 60° 57' West parallel with and 44
feet, measured at right angles northerly from the
center line of Santa Ana Street, 20 feet;

12 Thence North 74° 03' East a distance of 16.97
feet;

13 Thence North 29° 03' East parallel with and 33
feet, measured at right angles westerly from the
center line of Orange Street to the northeasterly
line of said Lot 57;

14 Thence South 60° 57' East a distance of 8 feet;

15 Thence South 29° 03' West, parallel with and
25 feet measured at right angles westerly from the
center line of Orange Street, to the point of be-
ginning.

16 (c) The City Clerk is authorized and directed to cause
17 a copy of this resolution to be recorded by the County Recorder
18 of Riverside County.


