

RESOLUTION NO. 8240

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A RIGHT OF WAY EASEMENT FOR DRAINAGE PURPOSES IN E. N. SMITH'S SUBDIVISION.

WHEREAS, on May 6, 1958, the City Council of the City of Riverside adopted a Resolution No. 8192, declaring its intention to order the vacation of a right of way easement for drainage purposes therein described, and fixing the time and place for hearing all persons interested in the proposed vacation, pursuant to the provisions of the Public Service Easements Vacation Law, being Sections 50430 et seq., of the Government Code; and,

WHEREAS, said proposed vacation was submitted to and acted upon by the Planning Commission, and notice of hearing said resolution was given as provided by said Public Service Easements Law; and,

WHEREAS, on the day fixed for the hearing the City Council heard and considered the evidence offered by persons interested, and found, and hereby finds, from all of the evidence submitted that the right of way easement for drainage purposes hereinafter ordered vacated is unnecessary for present or prospective public use.

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that a right of way easement for drainage purposes in E. N. Smith's Subdivision in the City of Riverside, County of Riverside, State of California, and described as follows:

The southerly fifteen feet (15') of Lot 32, E. N. Smith's Subdivision, as shown on a map recorded in Map Book 5 at page 179, Records of Riverside County, EXCEPT the easterly five feet (5') thereof;

is unnecessary for present or prospective public use, and that the same be and is hereby vacated.

IT IS FURTHER ORDERED that the City Clerk of said City of
