2 ARLINGTON MUTUAL WATER COMPANY, a corporation, Grantor, for a
3 valuable consideration, receipt of which is hereby acknowledged,
4 does hereby remise, release and forever quitclaim to the CITY OF
5 RIVERSIDE, a municipal corporation, the real property in the
6 City of Riverside, County of Riverside, State of California,
7 described as follows:

All of Lot 77 and those portions of Morris Street, and
Lots 75 and 76 of the McClaskey Tract, as recorded in Map
Book 10, pages 36 and 37, Records of Riverside County, lying
Easterly of the Easterly line of the spur track deeded to
the United States of America by deeds recorded in Book 568,
page 323, and Book 569, page 219, Official Records, Riverside
County, California;

All of Lots 6, 7, 8, 9, and those portions of Lots 5 and 10
of McClaskey Tract No. 2 as recorded in Map Book 14, page 27,
Records of Riverside County, lying Easterly of the Easterly
line of the spur track deeded to the United States of America
by deed recorded in Book 570, page 53, Official Records of
Riverside County;

EXCEPTING THEREFROM the Northerly 7 feet of said Lots
5, 6, and 7.

Also all that property beginning at the Southeasterly corner
of property conveyed to Riverside Groves and Water Company
by deed recorded in Book 288, page 169 of Deeds, Riverside
County Records, said Southeasterly corner being the
Southerly boundary of Rancho La Sierra and being in Section
31, Township 2 South, Range 5 West, San Bernardino Base and
Meridian; thence South 89° 35 3/4' West, along said South-
erly boundary of said Rancho, 350.6 feet; thence North
0° 1 1/2' East 745.47 feet; thence North 89° 35 3/4' East 350.6
feet, to a point on the Easterly line of the property of
said Water Company as deeded by W. J. Cole et al; thence
South 0° 1 1/2' West, along said Easterly boundary line of said
Water Company property, 745.47 feet, to the point of begin-
ning;

water ditches and canals located thereon, and all power and
electric lines, conduits, poles, and wires for conducting
electricity, located thereon; together with all rights of way
and easements in, under, and across said land.

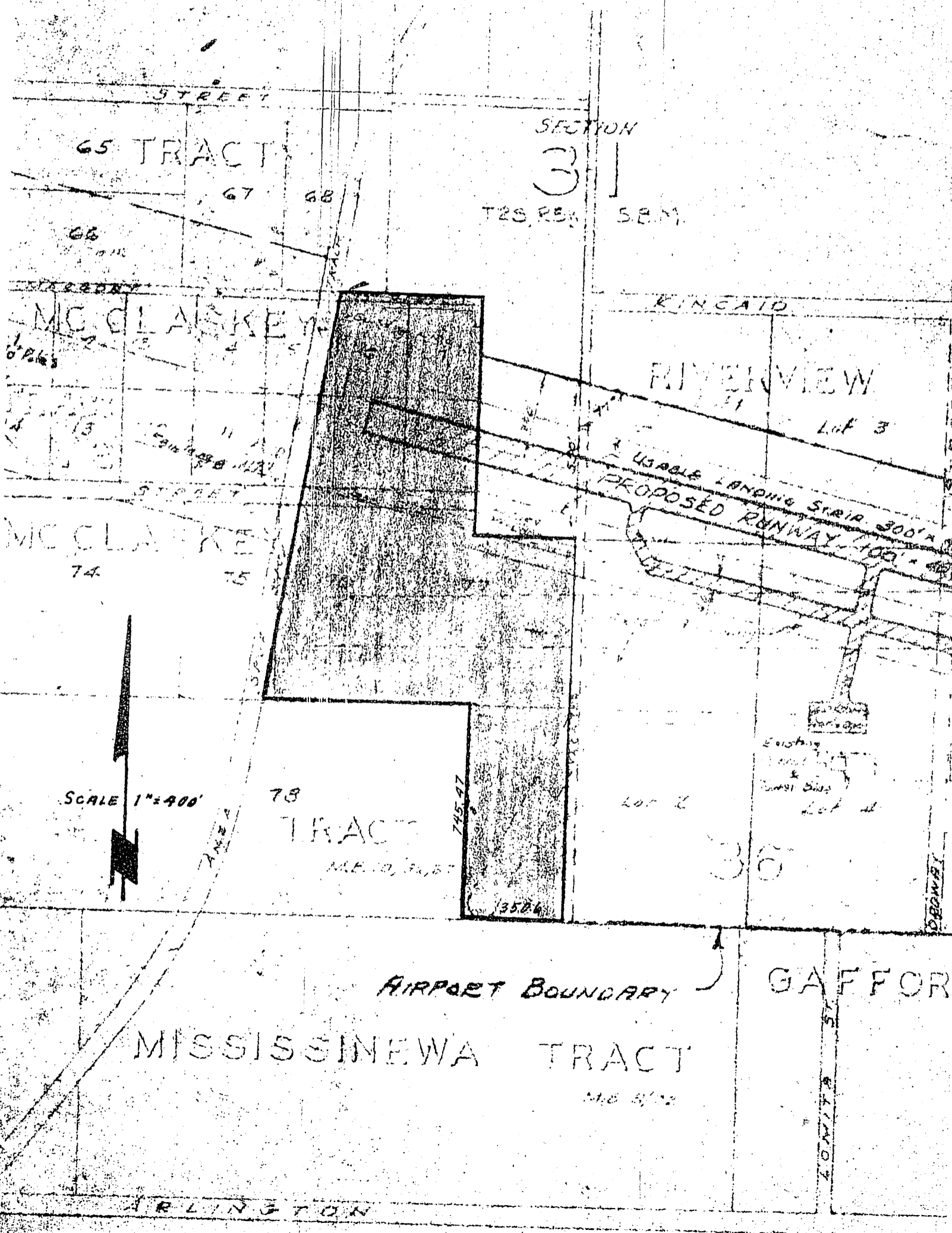

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
RIVERSIDE, CALIFORNIA, ACCEPTING A DEED

BE IT RESOLVED, that a Quitclaim Deed, dated June 10, 1958, executed by the Arlington Mutual Water Company, a corporation, by F. P. Miller, President, and William F.
