RESOLUTION NO. 8324

DEPT OF PUBLIC WORKS

1 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
2 RIVERSIDE, CALIFORNIA, MAKING ITS FINDINGS AND
3 DETERMINATIONS IN THE MATTER OF ORDINANCE OF
4 INTENTION NO. 2547, AND ORDER OF VACATION IN
5 THE MATTER OF VACATING A CERTAIN UNNAMED STREET.

6 WHEREAS, the City Council of the City of Riverside, Cali-
7 fornia, adopted an ordinance of intention, No. 2547, pursuant
8 to the provisions of the Street Vacation Act of 1941, being
9 Part 3, Division 3 of the Streets and Highways Code of the
10 State of California, declaring its intention to vacate a
11 certain unnamed street, therein and hereinafter described; and,

12 WHEREAS, the matter came on regularly for hearing before
13 said City Council at the time and place fixed for hearing by
14 said ordinance of intention, and said City Council heard and
15 considered all of the evidence submitted.

16 NOW, THEREFORE, BE IT RESOLVED by said City Council that
17 it be and is hereby found and determined by said City Council
18 that said ordinance of intention was duly passed, adopted and
19 published in the manner prescribed by law for the adopting and
20 publishing of ordinances of said City, and the notice of said
21 vacation proceedings and of the time and place of hearing was
22 given by posting, as provided by the Street Vacation Act of
23 1941, and that the said unnamed public street therein described
24 is unnecessary for present or prospective public purposes and
25 should be vacated.

26 NOW, THEREFORE, pursuant to the provisions of the said
27 Street Vacation Act of 1941, IT IS HEREBY ORDERED by the City
28 Council of the City of Riverside, California, that the said
29 unnamed street in the City of Riverside, County of Riverside,
30 State of California, described as follows, to wit:

31 The westerly 33 feet of the west one-half of
32 the northwest one-quarter of the northwest one-quarter
of the southeast one-quarter of Section 33, Township

1 2 South, Range 5 West, San Bernardino Base and
2 Meridian, as shown by map of subdivision of
3 Section 13 and fractional Section 22 in Township 2
4 South, Range 5 West, San Bernardino Base and Meridian,
on file in the Book 2, page 2, Records of San Bernardino
County, California;

5 EXCEPTING THEREFROM, the Westway 44 feet included
6 within Webster Avenue;

7 to, and the same is hereby vacated.

8 IT IS FURTHER ORDERED that the City Clerk of said City of
9 Riverside shall cause a certified copy of this order, attested
10 by the City Clerk under the seal of said City, to be recorded
11 in the office of the County Recorder of Riverside County,
12 California.
