Commencing at the west one-quarter corner of said Section 35, said corner being on the center line of Central Avenue; thence South 89° 49' 04" East, along the center line of said Central Avenue, 271.01 feet; thence South 0° 10' 56" West, 25.00 feet to the True Foint of Beginning.

Thence South 24° 54' 52" West, 46.95 feet; thence South 40° 29' 12" West, 50.93 feet; thence North 50° 26' 57" West, 35.45 feet; thence North 16° 22' 12" East, 32.28 feet; thence North 89° 49' 04" West, 106.54 feet to a point on the southeasterly line of the State Freeway; thence North 75° 03' 04" East, along said southeasterly line, 107.26 feet to a point on the southerly line of said Central Avenue; thence South 89° 49' 04" East, along the southerly line of said Central Avenue, 73.99 feet to the True Point of Beginning.
