A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A RIGHT OF WAY EASEMENT FOR DRAINAGE PURPOSES IN, OVER AND ACROSS LOTS 1 AND 8 IN BLOCK 13 OF LANDS OF THE RIVERSIDE LAND AND IRRIGATING COMPANY.

WHEREAS, it appears that the City of Riverside has an easement and right of way for drainage purposes, over and across Lots 1 and 8, in Block 13 of Lands of the Riverside Land and Irrigating Company, along the course hereinafter described; and,

WHEREAS it appears that said easement and right of way is no longer necessary for present or prospective public use;

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that said easement and right of way for drainage purposes be and the same is hereby vacated. The said easement is situate in the City of Riverside, County of Riverside, State of California, and is described as follows:

That certain drainage easement and right of way, 6 feet in width, over and across Lots 1 and 8, Block 13 of Lands of the Riverside Land and Irrigating Company as shown by map on file in Book 1, page 70 of Maps, Records of San Bernardino County, California, as conveyed to the City of Riverside, a municipal corporation of the State of California, by deed recorded June 1, 1925, in Book 544, page 424 of Deeds, Records of Riverside County, California, and that portion of said easement and right of way as conveyed to the said City of Riverside, by deed recorded March 9, 1925, in Book 544, page 383 of Deeds, Records of said Riverside County; the center line of said easement and right of way being described as follows:

Beginning at a point on the northwesterly line of said Lot 1, a distance of 25 feet northeasterly from the most westerly corner of said lot;

Thence southeasterly, parallel with the southwesterly line of said Lot 1 and the southwesterly line of said Lot 8 to the southeasterly line of said Lot 8.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this resolution

2 City, to be recorded in the office of the County Recorder of
3 Riverside County, California.
