

SEWER R/W IN BLK. 12 RANGE 11

We, A. L. RAMAGE, ( an unmarried man), HARRY A. WESTERFIELD, 1919  
and ELSIE M. WESTERFIELD, his wife, and Mrs. ANNA VAN KIRK, (a widow), all  
of the City of Riverside, County of Riverside, State of California,

DO HEREBY GRANT unto the City of Riverside, a municipal cor-  
poration, for the purpose of a Right of Way for a Sewer., a certain strip  
of land in the City of Riverside, County of Riverside, State of California,  
particularly described as follows, to-wit:

A strip of land extending one foot on each side of a line begin-  
ning at a point on the Southerly line of Block 12, Range 11 of the Town  
of Riverside, as surveyed by Goldsworthy and Higbie, a plat of which is of  
record in the office of the County Recorder of the County of San Bernardino  
State of California, and two hundred and ten (210) feet Westerly of the  
Southeasterly corner of said Block 12 for an initial point; thence Northerly  
and parallel with the Westerly line of said Block 12. a distance of 285  
feet to a point; said line to define the middle line of a strip two feet
