RESOLUTION NO: 8546

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING RIGHT OF WAY EASEMENTS FOR PUBLIC UTILITY PURPOSES LYING BETWEEN OLD RANCH ROAD AND GRAND AVENUE.

WHEREAS, it appears that the City of Riverside has easements and rights of way for public utility purposes lying between Old Ranch Road and Grand Avenue, along the course herein-after described; and,

WHEREAS, it appears that said easements and rights of way are no longer necessary for present or prospective public use

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that said easements and rights of way for public utility purposes be and the same are hereby vacated. That said easements are situate in the City of Riverside County of Riverside, State of California, and described as follows:

Those certain 5.00 foot public utility easements, lying between Old Ranch Road and Grand Avenue and parallel with said Grand Avenue, as shown on plat of Record of Survey on file in Book 26, at page 41, Records of Surveys, Records of Riverside County, California.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside cause a certified copy of this resolution and order, attested by the City Clerk under the seal of said City, to be recorded in the office of the County Recorder of Riverside County, California.
