EASEMENT

FOR VALUABLE CONSIDERATION, THE GAGE CANAL COMPANY, a California corporation, does hereby grant to the CITY OF RIVERSIDE, a municipal corporation, a non-exclusive easement for the construction, maintenance, operation, repair and replacement of a sixteen inch concrete storm drain pipeline over, under and upon the following described real property situated in the County of Riverside, State of California:

> That portion of the south half of the northeast quarter of Section 36, Township 2 South, Range 5 West, San Bernardino Base and Meridian, more particularly described as follows:

Beginning at the northeast corner of Lot 4 of the Church Subdivision, as shown by map on file in Book 6 of Maps, at Page 55 thereof, Records of Riverside County, California, said corner being on the south line of the Gage Canal Company right of way (50 feet in width);

Thence North 72° 27' West along said south line, a distance of 93.51 feet to a point thereon;

Thence, at a right angle, North 17° 33' East, a distance of 10.00 feet;

Thence South 72° 27' East and parallel with said south line, a distance of 270.00 feet;

Thence South 17° 33' West, a distance of 10.00 feet to a point in said south right of way line;

Thence North 72° 27' West along said south line, a distance of 176.49 feet to the point of beginning.

By acceptance of this deed, Grantee agrees that the pipeline shall be constructed and located in the centerline of the above described easement, and this conveyance shall be subject to all existing pipelines in or across the property. Grantee also agrees that the pipeline shall be installed at least two and one-half feet below the surface of the ground, and shall be kept in good condition and repair. Grantor shall not be liable for any damage to the pipeline caused by travel of vehicles or equipment over the property included in this easement. Upon abandonment of this easement by the Grantee, or its successors or assigns, or if this easement is no longer used for the purposes provided herein, the easement shall cease and determine and revert to the grantor, its successors and assigns, and the Grantee shall have no further interest or rights in the property described herein.
