

We, the undersigned, of the City of Riverside, County of Riverside, State of California, hereby GRANT to the City of Riverside, a municipal corporation organized and existing under and by virtue of the laws of the State of California, a right of way for a sewer over and along the following route, to-wit:-

Beginning at a point in Block 5, Range 2 of the town, now City of Riverside, as recorded in Book 7. at page 17, Records of San Bernardino County, State of California, said point being 163 feet easterly of the westerly line and 155 feet northerly of the southerly line of said block; thence southerly and parallel with the westerly line of said block a distance of 55 feet to a point; thence in a southeasterly direction a distance of 105.5 feet more or less to a point, said point being 265 feet easterly of the westerly line and 73 feet northerly of the southerly line of said Block; thence easterly and parallel with the southerly line of said block a distance of 30 feet.
