Commencing at a point on the Westerly line of Locust street distant One Hundred and Fifty-seven and one-half (157 1-2) feet Southerly from the North-easterly corner of Block Five (5), Range Twelve (12) of the Town of Riverside, as surveyed by Goldsworthy and Higbie, a plat of which survey is of record in the office of the County Recorder of the County of San Bernardino, State of California, in Book 7 of Maps, at page 17 thereof; thence at a right angle Westerly, parallel with Fifth Street, Three Hundred and Thirty (330) feet to the Easterly line of Cedar Street; thence at a right angle Southerly along the Easterly line of Cedar Street, Fifteen (15) feet; thence at a right angle Easterly, parallel with Fifth Street, Three Hundred and Thirty (330) feet to the Westerly line of Locust Street; and thence at a right angle Northerly along the Westerly line of Locust Street Fifteen (15) feet to the point of beginning.
