

THIS INDENTURE, made this 1922 day of November.

1912, by and between the FIRST NATIONAL BANK CF RIVERSIDE,
a corporation, Grantor, and the CITY OF RIVERSIDE, a municipal corporation organized and existing under the laws of the State of California, Grantee:

WITHESSETH: - That for a valuable consideration the said Crantor hereby grants, conveys and confirms to the said Crantee a piece or parcel of land situate, lying and being in the City of Riverside, County of Riverside, State of California, described as follows, to-wit:-

Beginning at a point in the common boundary line of Lots 173 and 174 of the Southern California Colony Association Lands, a man of which is of record in Book No. 7 of Maps, page 3, Records of San Bernardino County, State of California, and 44.9 feet Northerly of the common corner of Lots 173, 174, 189 and 190 of said lands for an initial point; thence at right angles Easterly a distance of 30 feet to a point; thence Mortherly and parallel with the Easterly boundary line of Lot 174 of said lands a distance of 268.57 feet, more or less, to a point on the Southerly line of Lorth Street; thence Westerly along the Southerly line of Morth Street a distance of 30 feet to a point; thence Southerly along the Easterly boundary line of Lot 174 a distance of 268.5 feet, more or less, to the initial point.

TO HAVE AND TO HOLD the same unto the said Crantee for the purposes of a public street.
