

This Indenture, Made the 17th day of February 1914 in the year of our Lord one thousand nine hundred and fourteen

between RUBIDOUX BUILDING COMPANY, a corporation organized and existing under the laws of the State of California,

part Y. of the first part, and CITY OF RIVERSIDE, a municipal corporation,

part Y of the second part,

Witnesseth: That for and in consideration of the sum of \$10.00

Ten and no/100 DOLLARS,

in hand paid by the said part Y... of the second part, the receipt whereof is hereby acknowledged, the said part Y. of the first part do es by these presents grant, bargain, sell and convey unto the said part Y. of the second part, and to its successors all those certain lots or parcels of land situate in the City of Riverside, County of Riverside, in the State of California, and bounded and particularly described as follows, to-wit:

Beginning at a point in the Southerly line of the El Padro Rancho Resubdivision, a map of which is of record in Book of Maps 8, page 14, records of Riverside County, California, said point being South 56° 00' West 1126.0 feet from the Northeast corner of said Resubdivision; thence North 34° 00' West, 400 feet; thence North 56° 00' East, 517 feet; thence South 89° 41' West, 139.74 feet to the beginning of a curve having a radius of 15 feet, convex to the Northeast; thence along said curve a distance of 38.3 feet to the end of the curve; thence South 56° 00' West, 442.41 feet; thence South 34° 00' East 450 feet to a point in the South line of the El Padro Rancho Resubdivision; thence North 56° 00' East, 50 feet along the Southerly line of said tract to the initial point.

ALSO:- Beginning at a point South 56° 00' West 1126.0 feet and North 34° 00' West 200 feet from the Northeast corner of said El Padro Rancho Resubdivision; thence North 56° 00' East 816.75 feet; thence South 89° 41' West 27.05 feet; thence South 56° 00' West 794.61 feet; thence South 34° 00' East 15 feet to the initial point.
