

THIS INDENTURE, Made this 3d day of March, 1914, by and between A. B. CANTARINI and DAISY CANTARINI, his wife, of the City of Riverside, Grantors, and the CITY OF RIVERSIDE, a municipal corporation organized and existing under the laws of the State of California. Grantee:

WITNESSETH:- That for a valuable consideration the Grantors hereby grant to the said Grantee a strip of land situate, lying and being in the City of Riverside, County of Riverside, State of California, and particularly described as follows:-

Beginning at a point on the Northerly line of Lot 38 of the Overlook Ridge Tract, as recorded in Book 4 of Maps, page 94, Records of Riverside County, State of California, said point being 36.8 feet Westerly of the Northeast corner of said Lot 38; thence Easterly 36.8 feet to the Northeast corner of said lot; thence Southerly along the Easterly line of said Lot 38 a distance of 36.8 feet to a point; thence in a Northwesterly direction and on the arc of a circle having a radius of 50 feet and convex to the Northeast a distance of 63.5 feet, more or less, to the point of beginning.

TO HAVE AND TO HOLD the same unto the said Grantee for the purpose of widening North Almond Street at the angle.
