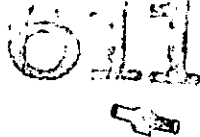

THIS INDENTURE, made and entered into by and between the under-
signed property owners, owning property on Brockton Avenue, in the City of
Riverside, parties of the first part, grantors, and THE CITY OF RIVERSIDE,
a municipal corporation, organized and existing under the laws of the State
of California, party of the second part, grantees;

WITNESSETH, That for and in consideration of the sum of one
dollar in hand paid by said party of the second part to the said parties
of the first part, the receipt whereof is hereby acknowledged, by each and
every one of the parties of the first part hereto, and for other valuable
considerations, the said parties of the first part do by these presents
grant, bargain, sell, quit claim, convey and confirm unto the said party
of the second part, and to its successors and assigns, forever, all of the
right, title, and interest of the undersigned property owners parties of
the first part in and to all of that certain lot or parcel of land situate
in the City of Riverside, County of Riverside, State of California, and
more particularly described as follows, to wit:

Beginning at a point in the north line of the southwest one-
quarter (S.W. 1/4) of the Fractional Section 34, Township 2 south,
Range 5 west, San Bernardino Base and Meridian, said point being
20 feet east of the northwest (N.W.) corner of the east one-half
(E 1/2) of the southwest one-quarter (S.W. 1/4) of said Section 34;
thence south and parallel to the west line of the east one-half
(E 1/2) of the southwest one-quarter (S.W. 1/4) of said Section to a
point in the south line of said Section 34; thence west on the
south line of said Section, 70 feet to a point 50 feet west of the
southwest (S.W.) corner of the west one-half (W 1/2) of the west one-
half (W 1/2) of the southeast one-quarter (S.E. 1/4) of the southwest
one-quarter (S.W. 1/4) of said Section 34; thence north and parallel
to said west line of the east one-half (E 1/2) of the southwest one-
quarter (S.W. 1/4) of said Section, to the easterly production of the
south line of Lot 48, Block 7, of the Tibbotts Tract, as recorded
in Book 4 of Maps, page 91, Records of Riverside County, State of
California; thence west on the easterly production of the south
line of said Lot 48, to the northeast corner of said Lot 48; thence
north on the east line of Lots 48, 49, 50, 51, 52 and Lot 1 of said
Block 7, to the northwesterly line of Magnolia Avenue; thence
northeasterly on the northeasterly production of the said north-
westerly line of Magnolia Avenue, to a point 60 feet west from the
west line of the east one-half (E 1/2) of the southwest one-quarter
(S.W. 1/4) of said Section 34, measured at right angles therefrom;
thence north and parallel to the said west line of the east one-
half (E 1/2) of the southwest one-quarter (S.W. 1/4) of said Section,
to the north line of the southwest one-quarter (S.W. 1/4) of said
Section; thence east on said line 80 feet to the point of beginning.

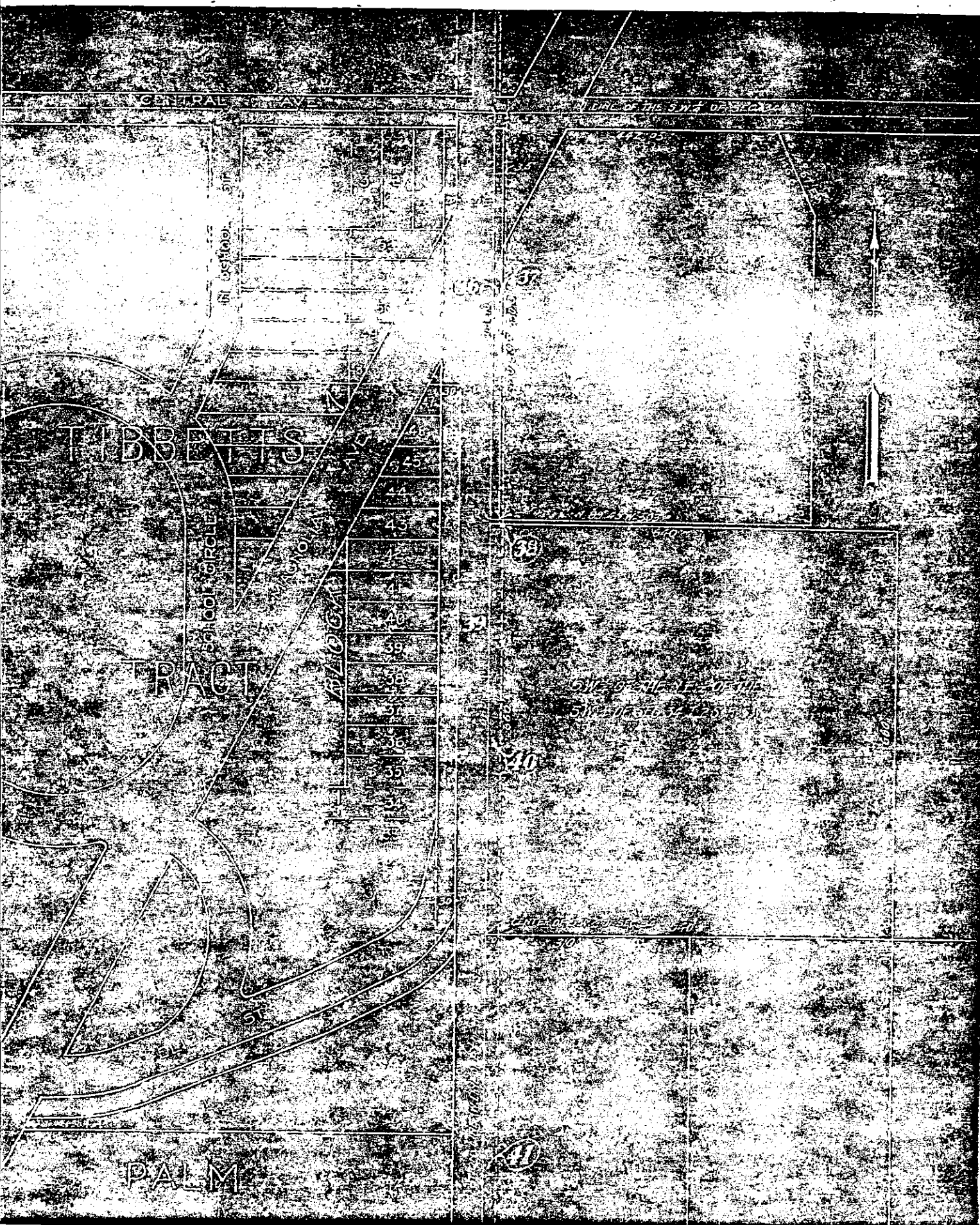
