line of Vine Street: thence southerly along said center
line of Vine Street as vacated by resolution recorded
in Volume 10, Page 595, Records of the Mayor and Common
Council of the City of Riverside, and distant uniformly
33 feet westerly from the westerly line of Block 10 -
Range 1 to the northerly line of Subway St. produced;
thence easterly along said northerly line of Subway
St. produced 33 ft. to the westerly line of said Block
