GRANT DEED.

WE, EMELINE JOHNSON AND LOUISE WHITE, as Executrices

and each of us, grant to the CITY OF RIVERSIDE, a Municipal Corporation of the State of California, for the purpose of a public alley, the following described premises, situate in the City of Riverside, County of Riverside, State of California, to-wit:

Beginning at a point on the southerly line of Seventh Street, 157.5 feet westerly from the northeasterly corner of Block 7 Range 8, of the Town of Riverside as shown on map, recorded in Book 7 of Maps, Page 17, Records of San Bernardino County, California; thence southerly at right angles to Seventh Street, a distance of 66 feet; thence at right angles westerly a distance of 7.5 feet; thence at right angles northerly a distance of 66 feet to a point on the southerly line of Seventh Street; thence at right angles easterly a distance of 7.5 feet to the point of beginning.

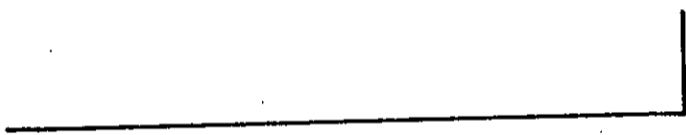

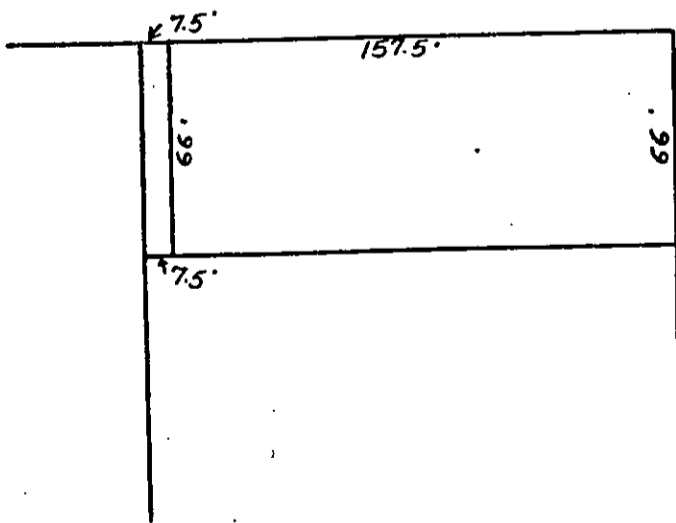
