
RESOLVED, this 9th day of January, 1923, by the Mayor and

1 THIS INDENTURE, Made this 30th day of December, 1922,
2 between the RIVERSIDE TITLE COMPANY, a corporation organized
3 and existing under the laws of the State of California, Grantor,
4 and the CITY OF RIVERSIDE, a municipal corporation organized
5 and existing under the laws of the State of California, Grantee:

6 WITNESSETH: That for a valuable consideration the
7 said Grantor hereby grants and conveys to the said Grantee an
8 easement of right-of-way for pole lines and wires, pipe lines,
9 sewers and other public utility lines over in and through that
10 certain piece or parcel of real property situate, lying and
11 being in the City of Riverside, County of Riverside, State of
12 California, being particularly described as follows, to-wit:

13 Commencing in the Northwestern corner of Lot D of
14 Elmwood Court Addition No. 2, a plat of which is of record in
15 Book 8 of maps, page 69, Records of Riverside County, California,
16 thence Easterly along the Northerly line of said Lot D 150 feet
17 to a point for beginning; thence Southerly and parallel with the
18 Westerly line of said lot D 94.4 feet; thence Easterly along
19 the Southerly line of said Lot D 8.5 feet; thence Northerly and
20 parallel with the Westerly line of said Lot D 94.4 feet; thence
21 Westerly 8.5 feet to the point of beginning.
