do hereby grant to the CITY OF RIVERSIDE, a Municipal Corporation,
the real property in the City of Riverside, County of Riverside, State of
California, described as follows:

BY MAP ON FILE IN BOOK 2, PAGE 110 OF RECORD OF SURVEYS,
RECORDS OF SAID RIVERSIDE COUNTY, WITHIN A STRIP OF LAND 60
FEET IN WIDTH, THE CENTERLINE OF WHICH IS DESCRIBED AS

LENGTH OF 43.55 FEET, THRU A CENTRAL ANGLE OF 8° 19' 05"
TO A POINT OF TANGENCY;

THENCE NORTH 24° 32' 55" EAST, 124.64 FEET TO THE BEGINNING
OF A TANGENT CURVE WITH A RADIUS OF 300.00 FEET AND CONCAVING
SOUTHEASTERLY;

THENCE NORTHEASTERLY TO THE RIGHT ALONG SAID CURVE AN ARC


