

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, unified RIVERSIDE/SCHOOL DISTRICT.

as Grantor , grants to the CITY OF RIVERSIDE, a Municipal Corporation of the State of California, as Grantee, its successors and assigns, a perpetual easement and right of way for the construction, reconstruction, maintenance, operation, inspection, repair, replacement, relocation, renewal and removal of storm drain facilities

together with all necessary appurtenances, in, under, upon, over and along that certain real property situated in the City of Riverside, County of Riverside, State of California, described as follows:

All those portions of Block 13, Range 9 and Range 10 of the Town of Riverside, as shown by map recorded in Book 7, Page 17 of Maps, records of San Bernardino County, together with those portions of Chestnut Street (abandoned), more particularly described as follows:

PARCEL 1

A strip of land 12.00 feet in width of which the centerline described as follows:

COMMENCING at the intersection of the centerline of Thirteenth Street with the centerline of Chestnut Street;

THENCE South 60° 56' 04" East, along said centerline of Thirteenth Street 10.00 feet;

THENCE South 28° 58° 24° West, 33.00 feet to the southwest line of said Thirteenth Street and to the true point of beginning;

THENCE continuing South 28° 58' 24" West, 0.48 feet to the beginning of a tangent curve with a radius of 45.00 feet and concaving northwesterly;

THENCE Southwesterly to the right along said curve an arc length of 25.69 feet, thru a central angle of 32° 42' 30'' to the end thereof;

THENCE South 61° 40° 54° West, 18.64 feet to a point hereinafter called Point "A" for description purposes;

THENCE North 73° 19' 06" West, 281.56 feet to the beginning of a tangent curve with a radius of 45.00 feet and concaving southeasterly;

THENCE Northwesterly, Westerly and Southwesterly along said curve an arc length of 51.89 feet, thru a central angle of 66° 04' 25" to the end thereof;

THENCE South 40° 36' 29" West, 199.46 feet to the northeasterly line of Fourteenth Street and to the end of this centerline description.

AREA - 0.160 of an acre.

PARCEL 2

A strip of land 12.00 feet in width of which the centerline described as follows:

BEGINNING at Point "A" described hereinabove;

THENCE South 73° 19' 06" East, 36.44 feet to the beginning of a tangent curve with a radius of 45.00 feet and concaving northerly;

THENCE Southeasterly to the left along said curve an arc length of 49.58 feet, thru a central angle of 63° 07' 14" to the southwesterly line of Thirteenth Street and to the end of this centerline description;

EXCEPTING therefrom all that portion within Parcel 1 hereinabove described.

AREA - 0.021 of an acre.

DESCRIPTION SPROVAL

TOGETHER WITH the right to clear and keep clear said easement and right of way from any structures or trees, to enter upon and to pass and repass over and along said real property, and to deposit tools, implements and other material thereon by Grantee, its officers, agents and employees and by persons under contract with said Grantee and their officers, agents and employees, whenever and wherever necessary for the purpose of constructing, reconstructing, maintaining, operating, inspecting, repairing, replacing, relocating, renewing and removing said storm drain facilities
