

GRANT DEED

JAMES L. WHITE, a single man,

FOR A VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, does hereby grant to the CITY OF RIVERSIDE, a Municipal Corporation, the real property in the City of Riverside, County of Riverside, State of California, described as follows:

All those portions of Lots 31 and 32 in Block 11 of White's Addition, as shown by map on file in Book 6 of Maps, at page 48 thereof, Records of San Bernardino County, California, more particularly described as follows:

Beginning at the most northerly corner of said Lot 32;

THENCE South 29° 43' 53" West along the northwesterly line of said Lot 32, a distance of 165.00 feet to the most westerly corner thereof; THENCE South 60° 13' 37" East along the southwesterly line of said Lot 32 and along the southwesterly line of said Lot 31, a distance of 120.00 feet to the most southerly corner of said Lot 31; THENCE North 29° 43' 53" East along the southeasterly line of said Lot 31, a distance of 10.50 feet to a point therein, said point being in a line parallel with and distant 10.50 feet northeasterly, measured at right angles, from the southwesterly line of said Lot 31; THENCE North 60° 13' 37" West along said parallel line, a distance of 86.63 feet to the beginning of a nontangent curve, concave to the east, having a radius of 39.50 feet, the radial line at said point bears South 52° 14' 51" West; THENCE northeasterly along said curve, to the right, through a central angle of 38° 20' 32". an arc distance of 26.43 feet to a point in a line parallel with and distant southeasterly 14.00 feet, measured at right angles, from the northwesterly line of said Lot 32, the radial line at said point bears North 89° 24' 37" West; THENCE North 29° 43' 53" East along said parallel line, a distance of 137.26 feet to a point in the northeasterly line of said Lot 32; THENCE North 60° 13' 12" West along said northeasterly line, a distance of 14.00 feet to the point of beginning. beschipton approval
